Textual Information()

The Company's application for listing approval made to BSE Limited of the 7992500 equity shares allotted on preferential basis to the promoter / non-promoters of the Company on 07-12-2016 is pending as BSE has directed the Company to disclose, the identity of ultimate beneficiary of four non-promoter HUF allottees and the post percentage shareholding of 122 non-promoter allottees to the shareholders and get the same ratified by the shareholders. The Company has since initiated a Postal Ballot process for the aforesaid mentioned disclosures and its ratification, result of which is scheduled to be declared on January 20, 2017. The Company shall after declaration of the results forward the ratification resolution to BSE for proceeding with the Company's application for listing approval. Further, the said allotted 7992500 equity shares are subject to lock-in as per SEBI Regulations, and accordingly, applications to the depositories (CDSL and NDSL) have been made by the Company for lock-in of the aforesaid allotted shares. Both the depositories are yet to effect the lock-in of shares for want of listing approval letter from BSE which is awaited.
