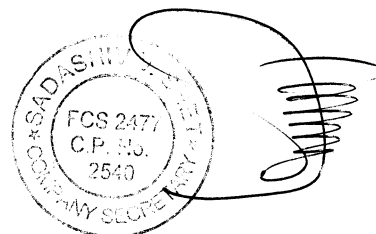

Dear Sir,

I, Sadashiv V. Shet, Practicing Company Secretary, had been appointed as a Scrutinizer for the purpose of scrutinizing the voting on the below mentioned resolutions through ballot paper at the 31st Annual General Meeting (31st AGM) of the Equity Shareholders of Hindustan Foods Limited held on Wednesday, August 10, 2016 at Dempo House, Campal, Panaji-Goa 403001 and through remote e-voting during the period from Sunday, August 07, 2016 (9:00 a.m.) to Tuesday, August 9, 2016 (5:00 p.m.) in a fair and transparent manner and for ascertaining the requisite majority on voting through ballot paper and remote e-voting carried out as per the provisions of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules 2014 as amended by the Companies (Management and Administration) Amendment Rules, 2015.

I hereby submit as under:

1. The remote e-voting period remained open from Sunday, August 07, 2016 (9:00 a.m.) to Tuesday, August 09, 2016 (5:00 p.m.) and was disabled for voting thereafter.
2. The Shareholders holding shares as on the "cut-off" date i.e. August 03, 2016 were entitled to vote on the proposed resolutions contained in the notice of the 31st AGM.
3. The shareholders details, such as their names, folios, number of shares held who had cast votes through remote e-voting were downloaded from the e-voting website of the National Securities Depository Limited in order to ensure that such shareholders did not vote again through ballot paper at the 31st AGM.



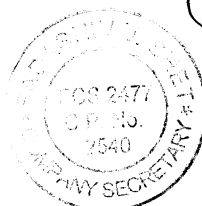
4. One ballot box kept for the purpose of voting through ballot paper was locked in my presence with due identification marks placed by me.
5. The locked ballot box was subsequently opened in my presence and the ballot papers were diligently scrutinized. The ballot papers were reconciled with the records maintained by the Company / Registrar and Share Transfer Agents of the Company and the authorizations lodged with the Company.
6. I did not find any ballot paper invalid.
7. After counting the votes cast by the shareholders present at the 31ST AGM through ballot paper, the votes casted through remote e-voting were unblocked on , August 10, 2016 at around 5.25 p.m. in the presence of two witnesses, Ms. Sushma Bandekar and Ms. Rakhi Malkarnekar, who are not in employment of the Company.
